- 1.1 All permits shall be assessed a non-refundable application fee of \$50.00.
- 1.2 Permit Fees: Permits and fees are non-refundable after work has started and non-transferable.  
  
Fences:           Industrial/Commercial - First 100 feet - \$50.00  
                      Each additional 100 feet                 - \$100.00  
                      Residential                                         - \$50.00
- 1.3 Contractor registration fee:  
                      Registration   \$50.00
- 1.4 An investigative fee equal of \$75.00, shall be assessed if a permit was not obtained prior to commencement of work.
