**RESOLUTION  
TO APPROVE THE WAIVER AND PLAN FOR THE GENERAL EMPLOYEES  
RETIREMENT PLAN, THE POLICEMEN AND FIREMEN RETIREMENT  
SYSTEM AND THE PUBLIC SAFETY RETIREMENT PLAN IN  
ACCORDANCE WITH PUBLIC ACT 202 OF 2017**

WHEREAS, the City of Highland Park General Employees Retirement Plan, the Policemen and Firemen Retirement System, and the Public Safety Retirement Plan are single-employer defined benefit pension plans; and

WHEREAS, these defined benefit pension plans are less than 60% funded and the actuarially determined contribution for all of the defined benefit pension retirement systems of the City of Highland Park is greater than 10% of City's annual governmental fund revenues, and

WHEREAS, under the provisions of Public Act 202 of 2017, the City of Highland Park is required to file an application for a waiver and plan for their defined benefit pension retirement systems to show their plan to address its underfunded status, and

NOW THEREFORE, the City Council received and filed the local government Retirement System Annual Report;

BE IT FINALLY RESOLVED, that the Highland Park City Council hereby approves the Application for Waiver and Plan; Defined Benefit Pension Retirement Systems for the General Employees Retirement Plan, the Policemen and Firemen Retirement Systems, and the Public Safety Retirement Plan.
