ADMINISTRATION:

The following communication was presented to Council.

There is water leaking into the hole where DTE Energy lines run (in the alley North of Glendale). While preparing to do their work, they noticed the water leaking into the manhole. They contacted us to make the repairs in order for them to make their electrical repairs. They cannot proceed with their repairs until the leak is stopped. Should this water sit too long, it could affect as many as 5000 residents being without power.

We have been working together with them to be on site while we sent out several contractors to get estimates on the work. Only one (1) company submitted an estimate for the repairs.




